

## **MIA Conflict of Interest Policy**

Manitoba Islamic Association (MIA) is a non-profit charitable organization with aim of serving the Muslim community in Manitoba. The elected officers of MIA, its paid staff and volunteers are expected to carry out their respective duties and serve the members of MIA according to Islamic ethics, professional standard and Canadian law.

Elected members of the executive council, board of trustees and volunteers and their respective family members are not allowed to make any personal financial gains by virtue of their position within MIA and access to its resources. Furthermore, MIA employees are expected to carry out their duties as per their employment agreements, job descriptions and as directed by the executive council.

MIA elected officers, volunteers and paid staff must abide by the following policies:

- MIA facilities, property or resources cannot be used for personal financial or material gain.
- MIA networks, affiliations, and associations cannot be used to promote the interests of a
  business, political party or affiliation, or any other organization in which they or an immediate
  family member is a stakeholder (member, owner, employee, share holder, etc...).
- Employees cannot engage in activities that are not part of their contractual agreement or normal employment activities during their work hours of employment or while on or using MIA facilities or resources.
- All MIA elected officers and employees must disclose any involvement in other organizations and political parties, or any other activity that may put them in conflict of interest with MIA.
- Full time employees must disclose all other forms of employment or income generating activities to the MIA executive council.
- Persons who represent MIA interests that have a conflict of interest cannot vote on issues or concerns that they have a conflict of interest with. A person who has a conflict of interest may be asked to leave the discussion for which the matter they have a conflict with is being discussed.
- If MIA elected officers and employees intent to seek run for political office, they must resign from the MIA prior to running for the position.
- If MIA elected officers intent to become an employee of the association, they must resign from their elected position.
- If any of MIA employee intent to run for executive council, they must resign from their position before running for the position.
